Project Title: Everbridge System

Program Area: IOE-

Project Description: This system is a direct relation to the State of Connecticut "reverse 911 system". This system will allow the LPD to develop a massive data base of contact information for town employees, town businesses and residents. This gives the LPD and the Town of Ledyard more than 30 delivery paths to contact and disseminate important public safety information as effectively and expeditiously as possible. This access will allow for unrestricted disbursement of information not only for the LPD but for all Town of Ledyard departments on an as need basis.

Planning Context: The Ledyard Emergency Communications Center currently has access to the State of CT Everbridge system to disseminate information to the public for specific emergencies. The previous and current Mayor has expressed interest in better communication with town residents. This was mainly due to complaints and concerns fielded from residents of lack of communication from the town especially during Hurricane Irene. This new access to the Everbridge System will allow the LPD and the Town of Ledyard a direct pipeline to deliver pertinent public safety information to the town residents and businesses.
