As I mentioned on the phone, there is no formal approval given that certifies a firm for meeting the requirements of a Historic Preservation Consultant as described in the Secretary of the Interior's Standards. Hi:

We are making some progress; but a couple things are holding us up. A portion of the funding is from the CT Historic Trust and they are asking for the name of the consultant doing the historic work and requiring that the firm meet the Secretary of the Interior's Qualifications for Historic Preservation. I don't know if this is a problem, but, let me know.

At the meeting last night, the issue of expenses came up. Can you just send me a note that the \$60,000 is a lump sum including expenses and the reimbursable expenses described in the terms would only apply to additional work authorized by the Town.

Once these are resolved, I anticipate that we could move forward within 2 to 3 weeks.
