Committee Mission Statement

- Assess unique opportunity of available property in Ledyard Center to meet community needs and improve Ledyard Center:
 - Develop recommendations for the future development or redevelopment of Ledyard Center;
 - Prepare a conceptual design recommendation for the future Ledyard Center;
 - Identify possible funding methods for Ledyard Center improvements; and
 - Recommend capital projects necessary to implement the future development or redevelopment of Ledyard Center.



Vision

- Create a vibrant New England village in Ledyard Center focused on an attractive Town Green:
 - Village implies an intensification and mixture of commercial, residential, and civic uses
 - Village also implies strong “sense of place” with harmonious streetscapes, walkways, and plantings
 - The Town Green is central to our vision because it will build upon social traditions while encouraging appropriate businesses
 - The density of a village allows for the critical mass necessary for economic success and for a pedestrian environment

With its own unique character, we hope that Ledyard Center will become a destination for shopping and for services, a home for diverse age groups, and a convenient gathering place for the broader community.



Recommendation

- Enhance the Fairgrounds as a Town Green
 - Small improvements (top soil, flag pole, tree plantings, stone wall along Route 117)
 - Provide a central focus around which development can occur consistent with Ledyard Center Village District regulations, and
 - Extend use of the fairgrounds for community events including the Ledyard Fair



Work by the Committee to Date

- Pursued State and Federal grant funds to support development of the Town Green and other infrastructure
- Town Planner secured a \$150,000 grant for the Town Green Improvements project from the Small Town Economic Assistance Grant Program (STEAP) with help from Sen. Prague and Rep. Reynolds
- Ledyard saw increased use of the Fairgrounds through the Farmers' Market in 2010
- Wrote request for proposals, engaged local landscape architectural firm Kent & Frost to develop landscape designs
- Gathered input from Ledyard Center School, Fair Association, Ledyard Lions
- Worked with Planning Commission, Zoning Commission and Architectural Review Board to secure approvals
- Conducted public information session February 17, 2011



Proposal

- Replace the existing chain link fencing along Route 117 with a 30" stone wall topped by a 24" high barrier fence
- Continue barrier fence along border with Ledyard Center School
- Install single row of red maple trees along Route 117 in front of the stone wall
- Plant an allee of honey locust trees along the fencing bordering Ledyard Center School
- Install brick pavers and steps on the northwest corner of the property to create an inviting entrance with a park bench and the sign that currently is located south of Colonel Ledyard Highway on Route 117
- Relocate existing exercise equipment within the plan



Decided not to Recommend

- Moving existing veterans memorial from Bill Library to the center (too expensive, no support)
- Planting a double row of trees between LCS and Fairground (trees compromise existing use by the fair)
- Split rail fence (does not serve as a child barrier)
- Wrought iron fence (cost, maintenance, effect)
- Working for approval of new bench design

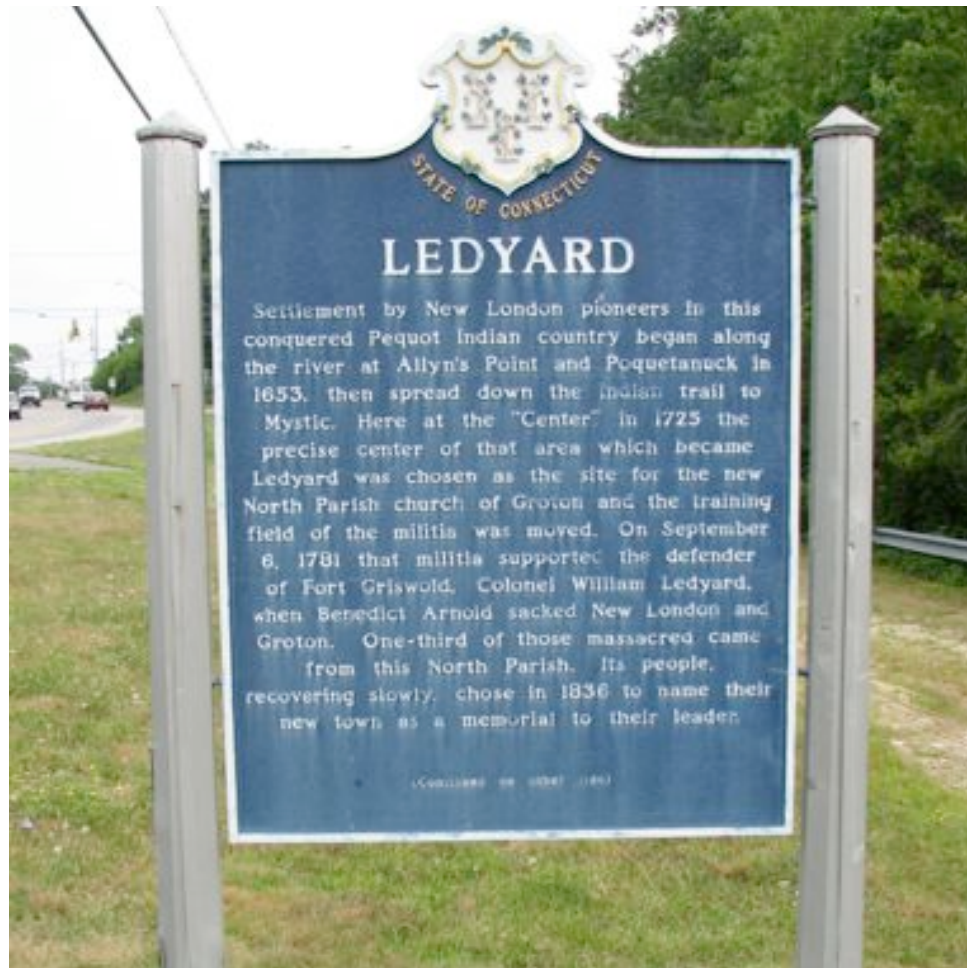

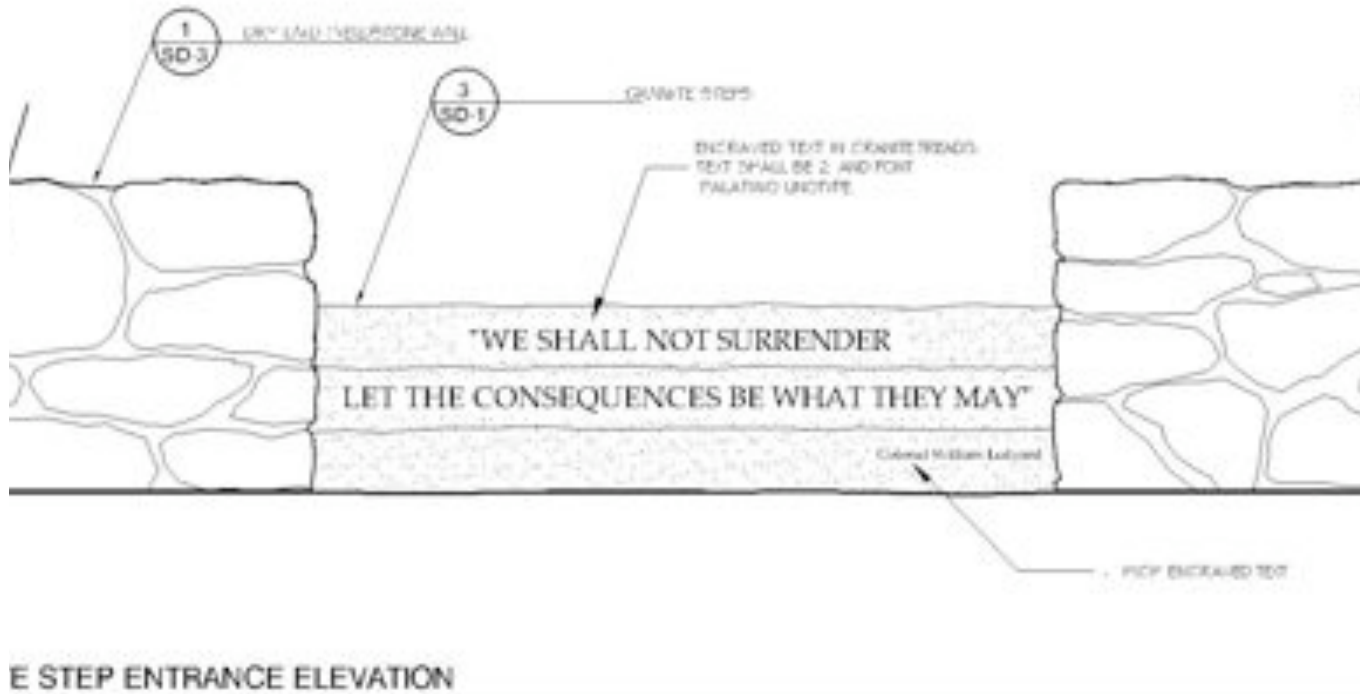

Original Plan - Aerial View



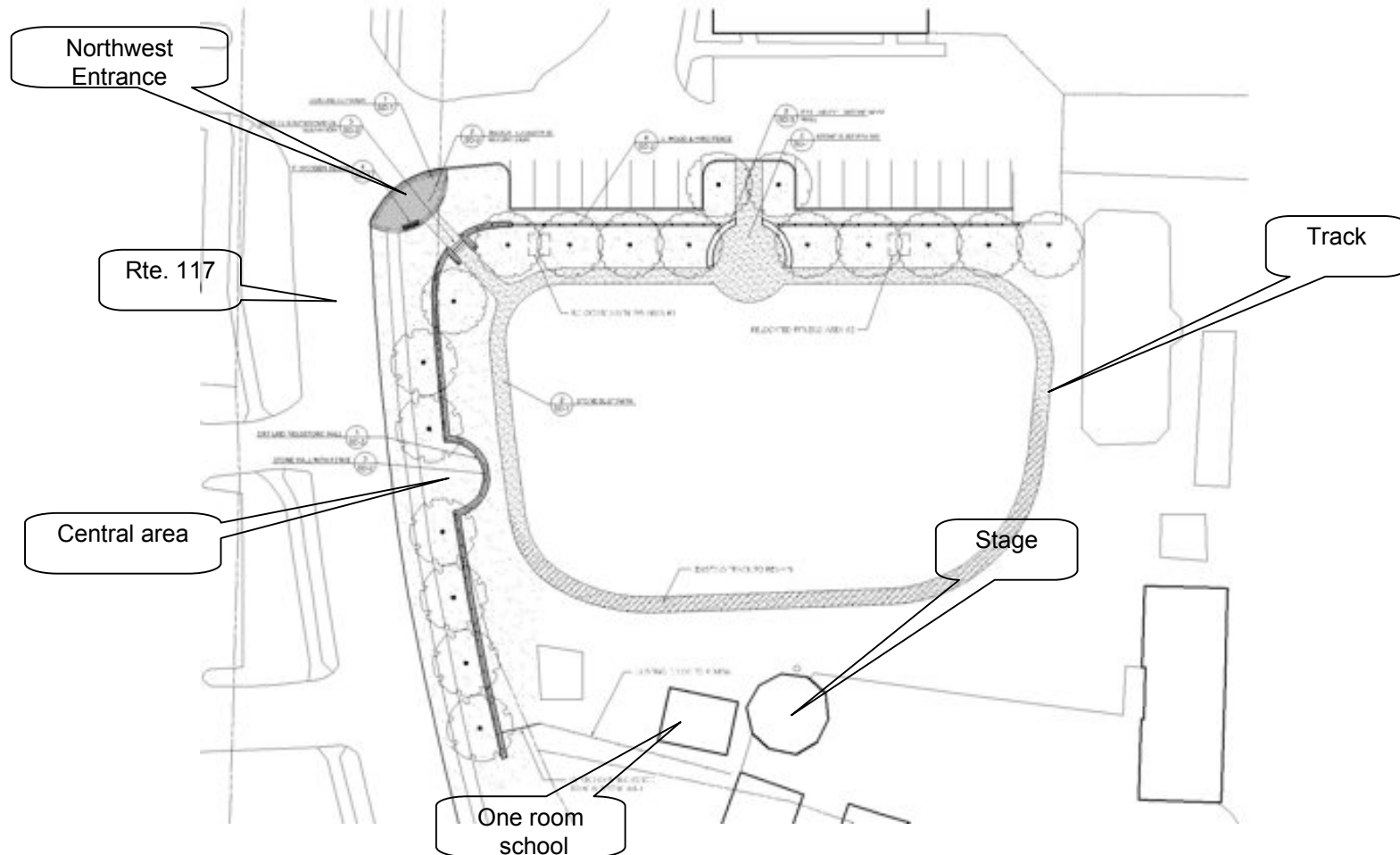

Current Aerial Design View



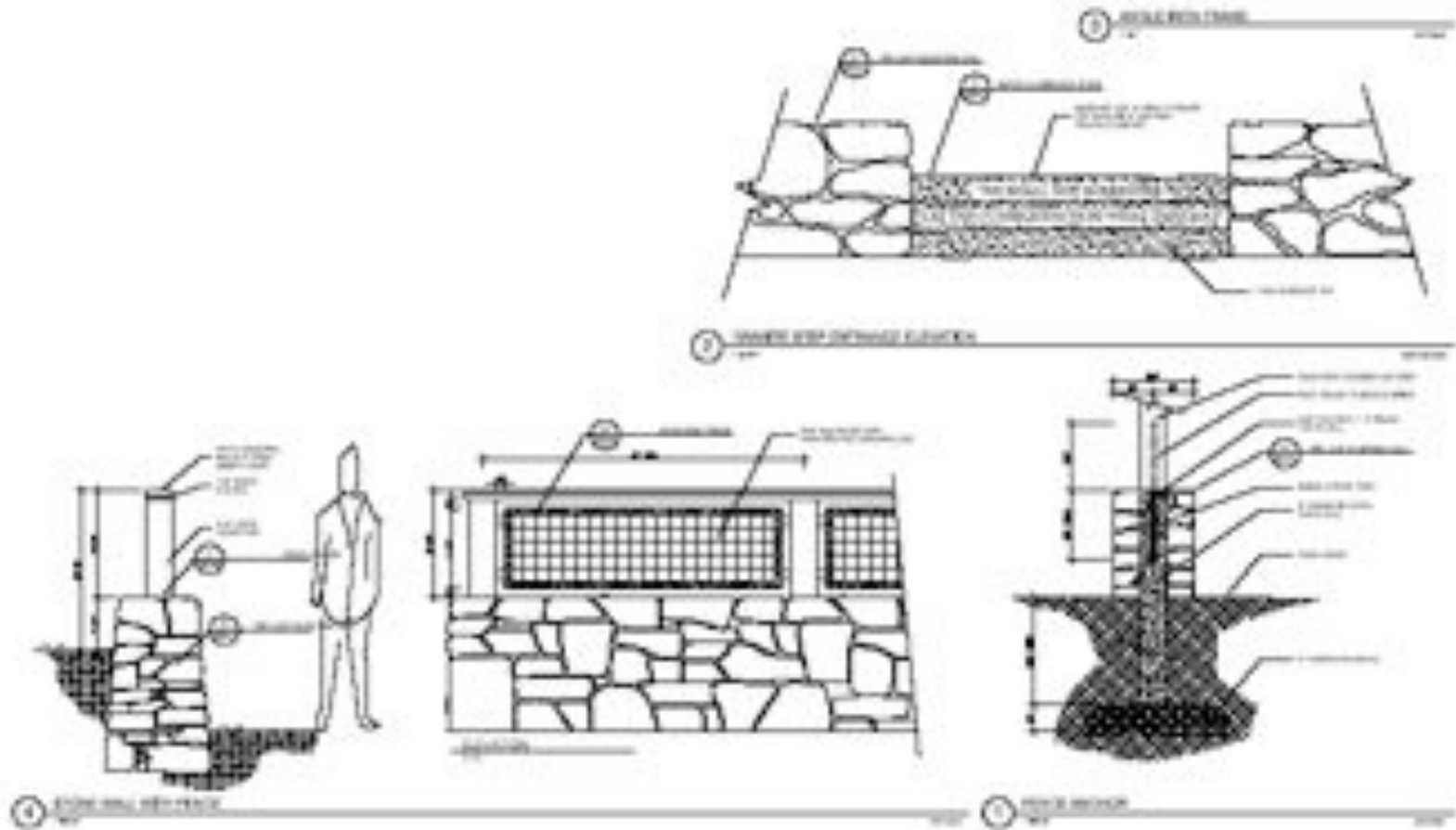

Future Consideration

- Installation of new stage, centrally located
- Realign the walking path
- Relocate the one room school house to a more prominent location
- Install a flagpole as shown at center
- Relocate overhead electric utilities underground
- Replace existing 'topsoil' and reseed Town Green



Request

- The Ledyard Town Center Committee requests the Town Council authorize the expenditure of the \$150,000 grant funding secured from the Small Town Economic Assistance Grant Program (STEAP) to implement the landscape architecture plan as presented at a cost not to exceed \$131,000.
- The Committee is willing to serve as the project manager
