- Execute the Agreement within fourteen days of receipt of Notice of Award.
- Furnish the required 100 percent (100%) Performance Bond and 100 percent (100%) Labor and Materials Bond within fourteen days of receipt of Notice of Award.

If this bid is accepted within the time stated, and we fail to provide the required bonds, the security deposit shall be forfeited as damages to the Owner by reason of our failure, limited in amount to the lesser of the face value of the security deposit or the difference between this bid and the bid upon which a Contract is signed.

In the event our bid is not accepted within the time stated above, the required security deposit will be returned to the undersigned, in accordance with the provisions of the Instructions to Bidders; unless a mutually satisfactory arrangement is made for its retention and validity for an extended period of time.

3. CONTRACT TIME

If this Bid is accepted, we will:

- Complete the Work within 150 consecutive calendar days after formal execution of the Notice to Proceed.

4. BIDDINGS LAWS

The wage rates assigned shall be in accordance with the schedule of minimum wages issued by the Commissioner of Labor for the State of Connecticut, in accordance with Chapter 557 of the General Statutes of Connecticut. It is the responsibility of the Contractor, before bid opening, to request, if necessary, any additional information on minimum wage rates for those trades people who may be employed for the proposed work under this contract.




